Whereas the Setteler is desirous of establishing a trust for public charitable objects.

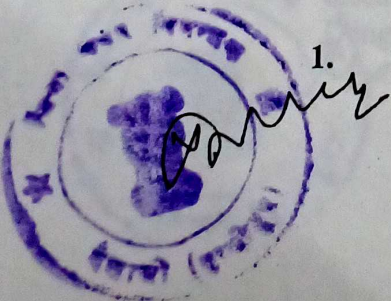
And whereas the trustees have, at the request of the setteler agreed to act as the first trustees of these presents as testified their being parties to and executing these presents.

And whereas it is necessary to declare the aims and objects of the public charitable trust, being constituted under these presents.

1. Now this indenture witnesses as follows:-

That, in order to effectuate her aforesaid desire, the settler has set apart and handed over to the trustees, a sum of **Rs. 51,000** (Fifty one Thousand) (hereinafter called the "Trust Fund" Which expression shall include cash and any other property of investments of any kind whatsoever in to which the same or any part thereof might be converted, invested or varied from time to time which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declaration hereinafter contained.

That the name of the trust shall be "**SHOBHANAND EDUCATIONAL TRUST**" and office will be situated at **Regd. Office:- VILLAGE- RAMPUR KICHNI, POST:- DESARI, P.S.- O.P CHANDPURA, (NEAREST P.S.- DESARI) DISTRICT:- VAISHALI, PIN- 844504 (BIHAR) [INDIA]** and/or at such other place or places as the trustees may decide from time to time.

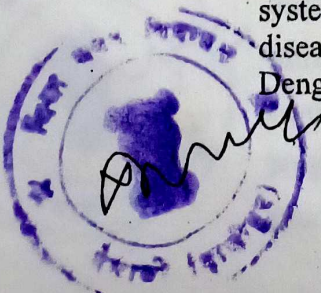
## 2. That the objects for which this trust is established are:

### I. → In the field of Human Resource Development: -

- To establish, develop, maintain technical and not technical institutions, C.B.S.E., I.C.S.E. schools, colleges, BEd. College, Coaching, Libraries & Librarian universities, laboratories, hostel for boys and girls, skill development centers, ITI College, Teachers Training College, Polytechnic College, competition, preparation centers, yoga and spiritual centers, sports training centers, vocational training centers, research and other institutions for the development and advancement of education and diffusion of knowledge among the public in general.
- To set motion and play a proactive role in giving direction for a quiet social movement/revolution for socio-technical, financial, ethical prosperity and take spearheaded initiative to spread the gain or prosperity in the benefit of throughout masses of world of living creature.
- To organize, promote, undertake, sponsor, carry-out, all programmes for the benefit of naturally-challenged person, schedule caste, schedule tribes, people under poverty line, old-aged, widow, orphan child, Divorced women, physically and mentally handicapped and down trodden irrespective of caste, creed, sex and religion such as: -

### II. → In the field of Health & Family welfare: -

- To undertake, establish, assist, organize or conduct the programme of research, management and infrastructure development in the field of health & family welfare.
- To establish, organize, run or maintain Hospital, Nursing College, Care and Care Centers, Para Medical College, Medical education and research centre in state-of-the-art.
- To undertake, organize, establish or run the medical education centre, college and research centre.
- To undertake awareness, prevention, surveillance, screening, management health systems and research programmes on Maternal and Child survival, communicable diseases like Malaria, Hepatitis, Leprosy, Meningitis, HIV/AIDS, STD, T.B., Dengue, non-communicable diseases like Cancer, Heart Diseases, Respiratory

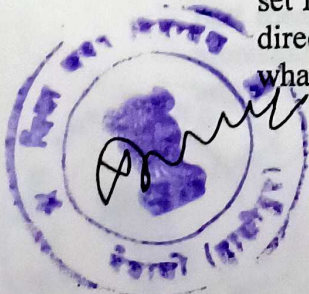




- c) To promote research development and adaptation of science and technology for improving quality of life of traditional artisans, landless labor and poor section of the Society.

x. **→ In the field of other programmes: -**

- a) To undertake, organize, investigate, participate, sponsor, and conduct, the Human rights, preservation of fundamental rights, Protection and safeguards to the victims of human rights, violations, for the freedom, dignity and peace of people. Also undertake case study, research, publications, treaties, with national and international institutions and foundation or endowment of award and prize, for effective implementation of Human Rights.
- b) To encourage, promote or develop alternative system of medicine i.e. Homeopathy, polymath, Aried, Yunani, Yoga, naturopathy, meditation, acupressure, acupuncture etc. Also promote preventive and curative health services.
- c) To organize or conduct all of the programmes of natural disaster management and ensure relief, rehabilitation of victims and set-up precautionary/pre-information mechanism of natural disaster.
- d) To organize or run the programmes for the development of culture, tourism, and national memorials, natural resources management, forestation and eco-development, environment education, environmental information system, technology up graduation/establishment/modernization of survey, test marketing & brand promotion, gender issues, promotion of blood, eye and human limbs donation, promotion Indian languages, prevention of atrocities on women, universalisation of elementary education, rural energy programme bio-gas development programme, khadi & sum scale industries promotion, administering, road safety programmes, social assistance programme, promotion of rural non-farm enterprises, rural and micro-financing.
- e) To organize or conduct the programmes or International peace, justice and co-operation, interchanges & interaction, legal aid and protection, awareness and consciousness building against social evils, social crime, terrorism stop programme, suicide prevention, prisoner education & welfare, community-based rehabilitation programme, fighting corruption and restructuring, labor issues, value added and sustainable programmes, consumer education and protection etc.
- [f] To acquire, hold, transfer, mortgage, lease out and dispose of and otherwise deal with property of the Trust in any manner whatsoever and get loan for the fulfillment of objective of the Trust.
- [g] To undertake, carryout, promote, sponsor, discharge, fulfill, participate, collaborate, manage or organize the programmes with people's co-operation, national and international Government and Non Government agencies and to carryout all necessary acts for the achievement of the objectives.
- [h] All the incomes, earnings, movable/immovable properties of the Trust shall be solely utilized and applied towards the promotion of its Aims and objects only as set forth in the deed of the Trust and no profit thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner whatsoever to the present or the past member of the Trust or to any person

upon the Trusts and with the subject to powers and provision including all the powers contained by and under these presents declared and contained concerning the Trust Fund which or the proceeds thereof, shall have laid out in purchase of property or properties as have laid out in purchase of property or properties as aforesaid or such of them as shall be then subsisting and capable of taking effect.

9. **That for the furtherance of the objects of the Trust, the trustees shall have the following powers:**

- (i) To accept any donation, contribution grant or subscription in cash or in kind, from any person(s) body of persons or trust, with or without conditions.
- (ii) To apply the whole or any part of the income of the Trust, or the trust fund or accumulations thereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.
- (iii) To sell, dispose of, alienate or otherwise deal with any property comprising the Trust Fund.
- (iv) To open account in the name of the Trust, with a Bank or Banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.
- (v) To adjust, settle, compromise, compound refers to arbitration, all actions. Suits claims, demands and proceedings regarding the Trust Fund.
- (vi) To engage or make provision for the engagement of any person (including all or any of the Trustees and committees or administrator or managing Trustees or otherwise) for the purpose of the administration of the Trust in such manner and subject to such rules and regulation as the Trustees may prescribe and also to engage or provide for the engagement.
- (vii) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and/or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.
- (viii) To start, abolish, discontinue and restart any charity of charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.
- (ix) To set apart and/or allocate the whole or a part of the income or the corpus of the Trust Fund or part thereof for any of the objects of the Trust.
- (x) To join, co-operate or amalgamate this trust with other or others having kindred or allied objects, upon such terms and conditions as the trustees may

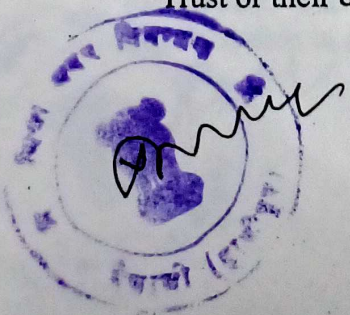

in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust.

- (xi) To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organizations or Trusts in India which may have been established or which may hereinafter be established for the like charitable purposes mentioned in these presents or any of them to enable such institution, societies, organisation or Trustees to start maintain, or carry out such charitable objects.
- (xii) To settle all accounts and to compromise, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.
- (xiii) To borrow money either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purposes of these presents, and it shall be lawful for the Trustee to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.
- (xiv) To apply to the Government, public bodies, urban, local municipal, district and other bodies, corporation, companies, or persons for and to accept grant of money and of aid, donations, gifts, subscriptions, affiliation and other assistance with a view to promote the objects of the Trust and to discuss and negotiate with the Government Departments, public and other bodies corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to put to any proper condition upon which such grants and other payments may be made.
- (xv) To take over or amalgamate with any other charitable trust, trustee, association, or institution with similar objects.
- (xvi) To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.
- (xvii) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.
- 10 The Trustees shall be accountable only for such money, and funds, which will actually come into their hands.
11. The Trustees will not be entitled to receive any remuneration, but the Trustee may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.

12. The managing Trustee for the time being will be at liberty to appoint additional Trustee within the number mentioned above for such period or on such terms as to retirement and re-appointment as the trustees for the time being consider proper.
13. A person shall cease to be a Trustee either:
- If he without leave of absence does not attend three consecutive meeting of the Trustees or for one calendar year, whichever is longer, or
  - If he is requested to resign by 3/4<sup>th</sup> or as near thereto as possible of the remaining trustees.
14. Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.  
The Trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations:
- (a) Five Trustees shall form a quorum for a meeting of the Trustees.
  - (b) All matters will be decided mutually by the Trustee.
  - (c) Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of two thirds of the trustees shall be as valid and effectual as a Resolution duly passed at a meeting of Trustees.
15. The Trustees shall have the power to determine in case of doubt whether any money or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoing ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorize the Trustees to spend the income or corpus of the Trust for any purpose not authorized by these presents.
16. The accounting year of the Trust shall be the financial year ending on 31<sup>ST</sup> March every year.
17. The Trust and the Trust funds shall be irrevocable for all the times.
18. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly.
19. Two-thirds majority shall situate the office of the Trust at **VAISHALI** unless changed by the Trustees.

**20. POWER & FUNCTION OF THE OFFICE BEARER**

**PRESIDENT:**

The President shall preside at all meetings of the Managing Trustee and of the trustee, when he is present and shall exercise such other powers as are conferred upon him by these rules. The President may call for an emergency meeting through President Signed notice in a shorter notice. The decision of President that a resolution has been

carried or lost shall be conclusive, unless such a decision is challenged and a poll is demanded; on poll being demanded, the same shall be taken in such manner as the President may in discretion determine. In case of a tie the President shall have a second or casting vote.

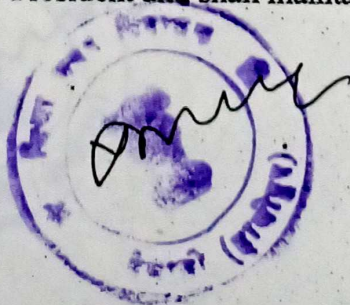
- a) He shall be in charge of the office and shall be responsible to general body in all matters. He will contract in all ways and means of the position of the association and shall have right to improve it.
- b) He shall be convener of all the meetings and without his signature on the notice of meetings no meetings will be valid.
- c) It shall be his duty to see that the resolution at the respective meeting are implemented and give to effect to timely.
- d) He shall be at liberty to spend for the purpose of the trustee without sanction of the Managing Trustee to do all such other lawful notes, deeds of things as incidental or conductive to the attachment of trustee.
- e) **Settler cum Managing Trustee and his legal depended shall be permanent holder of presidentship.**

**SECRETARY:**

- a) He shall produce the accounts of the trustee before Managing Trustee for approval.
- b) He will produce the expenditure of the trustee before the Managing Trustee for approval.
- c) He shall appoint, suspend, discharge, fix the salary, make payment of the employees of the institution and conducted by the trustee on behalf of the Managing Trustee.
- d) He shall maintain the account in proper and prescribed form. He shall deposit and withdraw the amount of the trustee in the bank or in the post office with the signatures of his own and also with counter joint signed by the Treasure or President.
- e) In the absence of President, the trustee will look after all powers conferred on Secretary.

**TREASURER:**

- a) The treasurer will act under the direction of the committee.
- b) Any amount exceeding Rs. 10,000/- which is not required for immediate use shall be paid into such bank or banks as may be approved or by the committee. The treasurer shall ordinarily receive all payments and disburse the amount passed by the President and shall maintain proper books of accounts.
